HOK Group, Inc. (“HOK” / “we” / “our” / “us”) is committed to protecting and respecting your privacy. This cookie policy and our [Privacy Policy](#) explain how any personal information that we collect from you, or that you provide to us, when using this site will be processed.

This policy explains what cookies are and explains how, as well as why, they may be stored on and accessed from your computer or device when you use of www.hok.com (the “Website”).

1. ***Our Website uses cookies.*** A cookie is a small piece of data (text file) that a website – when visited by a user – asks your browser to store on your device in order to remember information about you. This information might be about you, your preferences, or your device and is mostly used to make the site work as you expect it to. The information does not usually directly identify you, but it can give you a more personalized web experience. The specific cookies used by our Website are described in Section 8, below.

Cookies that are set by us are called first-party cookies. We also use third-party cookies, which are cookies from a domain different than the domain of the website you are visiting. With respect to third-party cookies used on our Website, we provided links to each third-party’s privacy policy in Section 8, below, if you are interested in additional information regarding those third-parties.

2. ***Session vs persistent cookies.*** Cookies can be usefully divided into two different types, session and persistent. Session cookies differ from persistent cookies primarily in that session cookies are temporary and expire and are normally deleted when you close your browser. Persistent cookies, in contrast, remain stored on your computer after you close your browser until they are deleted either because they expire or you delete them.
3. ***Your right to opt-out.*** Because we respect your right to privacy, you can choose to disable non-necessary cookies. You can change your cookie preferences at any time [here](#). Please note that blocking some cookies may impact your overall experience of our site.
4. ***Browser-based controls.*** You can set your browser not to accept cookies. To disable cookies through your browser, follow the instructions usually located within the ‘Help’ or ‘Tools’ menu of your browser. Further information on how to remove cookies from your browser can be found [here](#). In a few cases, however, some of our Website features may not work as a result. Also, note that disabling a cookie or category of cookies does not delete the cookie from your browser unless manually deleted via your browser.

a. **Necessary cookies.** Necessary cookies help make a website usable by enabling basic functions like page navigation and access to secure areas of the website. The website cannot function properly without these cookies.
